

#### ORDER

In accordance with the resolution of the Executive Committee Meeting of WBSH&FW Samiti issued vide no. SHFWS/Meeting & Matters – 13/2012/Pt.II/12325 dated 20.02.2020 and in supersession of all earlier orders in this matter, the upper age limit of all contractual employees under National Health Mission is hereby fixed maintaining parity with the retirement age of regular employees under State Government.

The maximum age limit for engagement and discontinuation of contract for any post under National Health Mission is given below:

Category No.	Name of the post	Maximum age limit for engagement	Upper Age limit till which contract can be renewed
1.	Medical Officers (Specialists / GDMO/FTMO/PTMO)	62 years	65 years (beyond which it will be judged on case to case basis with approval of the competent authority)
2.	Nursing Personnel	40 years	62 years
3,	All other contractual posts	40 years	60 years

- This order will not be applicable to such contractual posts under NHM which are designated for reengagement after retirement.
- This order will be effective from 01.04.2020.
- The contract of all contractual employees engaged against approved posts of National Health Mission who have crossed the upper age limit as mentioned in the above table, will not be renewed further beyond 01.04.2020.
- 5. The renewal of contract for the contractual employees enlisted under Category No. 1 beyond 65 years as on 01.04.2020, would be done once the details of such employees is submitted in a prescribed format.
- 6. The upper age limit criteria for renewal of contract will be calculated as on 1st April of the relevant Financial Year.
- All concerned are being informed for compliance.
